#### **REGISTRATION TERMS AND CONDITIONS**

#### **Definitions:**

- Member Symposium 6 7 November 2021 (the Event)
- Brisbane Convention & Exhibition Centre (the Venue)
- Skin Cancer College Australasia (the Organiser)
- The person named on the Event registration (**Delegate**)

## Registration:

  - a) Event registration will be refunded in full. No charge will apply for this change.
  - b) the Organiser will not be liable for any travel or accommodation cancellation costs incurred by the delegate.
